- **Meeting or exceeding all applicable Western Australian Work Health and Safety legislation, Environmental Protection obligations, Australian Standards and relevant industry codes**

3. Communicate and consult effectively

So that our workforce understands hazards, controls, expectations and their shared responsibilities for creating a safe workplace.

RESPONSIBILITIES

Top Management will:

- **Demonstrate visible leadership** and act as role models for safety across all operations.
- **Consult with workers** and, where applicable, their representatives on WHS matters, system changes, and improvements.
- Ensure this WHS Policy is **documented, maintained, communicated, and accessible** to all interested parties.
- Establish measurable objectives and targets and monitor performance through Management Reviews, internal audits and performance reporting.
- **Report, investigate, and close out actions** for all workplace incidents, near misses or hazards.
- Maintain a current **Legal & Other Requirements Register**, ensuring compliance with:
 - Work Health and Safety Act 2020 (WA)
 - Work Health and Safety (General) Regulations 2022 (WA)
 - Mines Act / Rail Safety where applicable
 - EPA requirements and environmental legislation
 - Relevant Australian Standards and Codes of Practice
- **Provide adequate resources**, including competent personnel, training, supervision, equipment and systems.
- Maintain certification to **ISO 45001:2018**, and support alignment with ISO 9001 and ISO 14001.
